#### **ELIGIBILITY**

- You can nominate anyone in lowa who is actively helping others through volunteer service. This includes individuals, families or groups, organizations or nonprofits, businesses or corporations, and national service members (current or alumni). We gladly accept posthumous nominations.
- Nominees must be doing volunteer work that helps their community, state, country, or
  even the world. Their service should be outside of their regular job duties. National
  service members can be nominated for going above and beyond in their assigned roles.
- You cannot nominate:
  - Past Hall of Fame inductees (click here to access the full list of inductees)
  - Current staff or commissioners of Volunteer Iowa
  - Employees of the Governor's Office

# WHAT TO INCLUDE IN YOUR NOMINATION

To be considered, your nomination must include:

- A completed nomination form
- At least one letter of recommendation
- One photo of the nominee (.jpg or .png format)

Do not include CDs, DVDs, newspaper clippings, notebooks, or other extra materials.

#### WHAT WE LOOK FOR

The nomination should describe the nominee's volunteer work in four key areas:

- **1.** Community Needs and Solution What problem did the nominee help solve? Did their work lead to lasting change?
- **2.** Connection Building How did the nominee help bring people together? Did they connect with groups outside their own organization?
- **3.** *Impact* What specific impacts did their work have? Did they improve lives or communities in a meaningful way?
- **4. Service Involvement** How much time was spent volunteering and leading the impacts? Did they use creative or new ways to solve problems?

#### **SELECTION AND RECOGNITION**

A panel of experts in volunteering will review all nominations and choose the honorees. Those selected will receive a letter from the Governor's Office inviting them to a special ceremony at the Iowa State Capitol. Their names will be added to the Iowa Volunteer Hall of Fame plaque at the State Historical Museum.

### **HOW TO SUBMIT YOUR NOMINATION**

We recommend writing your nomination in a Word document first. This helps you organize your thoughts and avoid losing work due to internet issues. You can submit your nomination in one of three ways:

- 1. Online (Preferred): visit volunteeriowa.org for the nomination form and instructions.
- 2. By Email: Send your materials to info@volunteeriowa.org Include "ATTN: Hall of Fame" in the subject line. Attach your nomination as a Word or PDF file, plus a photo (.jpg or .png).

## PART III: SHORT ANSWER QUESTIONS

Provide brief but specific information to address each of the essay questions. Every component of each question must be answered. There is a word limit for each question. **Use specific examples** to illustrate the scope and extent of the nominee's volunteer activities.

**Summary** — Provide a brief statement describing the nominee's history with volunteering, and why they are worthy of being selected for the lowa Volunteer Hall of Fame. (100 words or fewer)

**Community Needs and Solution** — Describe how the nominee's actions met or solved a real community need. Include specific information about how the activities led to a long-term solution. *Note: Volunteer Hall of Fame defines "community" broadly as that which benefitted from the nominee's service. Eligible service may occur at local, regional, state, national OR international levels.* (500 words or fewer)

**Connection Building** — Provide examples of how the nominee demonstrated hands-on service to build connections between the community and those who might be isolated from it. Explain if and how activities served those who are disconnected from the larger community. Explain if and how connections were made with groups beyond the agency for which the volunteer worked. (500 words or fewer)

**Impact** — List or describe the impact and benefits achieved because of the activities and efforts of this nominee (changes in the economy, environment, or social conditions). List or describe examples of the nominee's impact- e.g. funds raised, volunteers trained or recruited, partners established, programs created, people or communities served. Be as specific as possible. (500 words or fewer)
